Tell us about your firm or business including history, specialization, and years in business.

What's an interesting fact about you or your firm that most people don't know?

Interesting story that people may not know about me: I am a first generation born here in the U.S. My father fled a communist occupied country in the middle of the night when Soviets came to execute his entire family after my grandfather "deserted" the Soviet army because he refused to partake in the execution of innocents. They left in the middle of the night literally in a horse and wagon, and eventually made it to a refugee camp in Austria before making their way to the U.S. through Ellis Island. My mother also fled a communist occupied country, but she did so by being sold as a "bride" to the highest bidder in the U.S. My parents barely knew any English and struggled to make it. My mother never finished high school. However, they both persevered through hard work and with help from communities that supported them. I am forever indebted to my parents for their unrelenting devotion and love that allowed me to find my own path to succeed in life -- which saw my fair share of struggle, sacrifice, and many failures along the way. In part because he experienced a lot of negate work environments, which he believes were in large part due to his foreign accent and English being his second language, my father repeatedly encouraged me to "hang my own shingle" and "be my own boss." I am glad I listened to him because there is nothing more fulfilling that deciding your own destiny and creating a fair and generous work-environment for those who work with you.

What's a favorite moment of your career so far?

Bringing on an associate in my first year who has stayed with me all 11 years and is now my partner. I loved helping her (and especially watching her) develop from a highly intelligent but "green" attorney into to an incredibly confident, effective, and respected legal advisor to our clients.

What challenge are you most proud of overcoming?

One challenge that I am most proud of overcoming is being able to successfully keep my practice based out of NJ going (with the invaluable support from my law partner who hung in there with me during that crazy time) even after having to relocate to Arizona unexpectedly temporarily in 2013. It required me to fly back to NJ monthly and stay there for extended periods of a time, all while my husband and kids were in AZ. Eventually, the temporary situation became a permanent situation. I am now admitted in Arizona (as of 2020), and we are continuing to build Attorneys at Oscislawski LLC as a nationally recognized leader in our field.

Being selected to the Super Lawyers list in 2021 and 2020.

Tell us about a recent personal accomplishment of yours?

Raising two incredible and successful boys -- Adam (20) and Paul (15) who are such loving (and funny as heck!) humans, and the hardest workers I've ever met! They inspire me to be my best every day!

What advice would you offer new business owners?

Don't listen to ANYONE who tells you shouldn't or can't. I left "big law" in the year that I was likely to be made partner. I was told by my office managing partner at that time that I was "making the biggest mistake of my career." The year after I left and formed Attorneys at Oscislawski LLC, I doubled my take home salary -- and I've never once looked back. If you want to do it, you CAN -- no matter who you are or where you come from.

Supporting them by listening, sharing information, and providing them with opportunities for growth.
